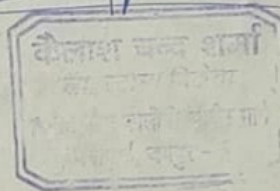

**I. MAIN OBJECT OF THE TRUST**

RAJASTHAN is rapidly developing state in India thickly populated people, advent of information technology has made the growth of the State faster in the towns which are growing to be as small metropolis but there is wide spread poverty and lack of education. People are not educated to a level of satisfaction. The trust is being made and settled to achieve such pious objects of spread of education, technology and over all welfare of the State.

**I. AIMS TO BE ACHIEVED BY THE TRUST**

- a) The TRUST shall spread the light of education and training amongst people at large in villages specially amongst poor, down troddens, disabled people and members of scheduled castes/scheduled tribes and other backward castes without any discrimination to caste creed or religion.
- c) The TRUST shall always with enthusiasm and expeditious zeal CARE for spread of education through schemes & programmes for Non-Formal education Research for designing & developing new assertive devices. To provide teaching aids, setup teacher training institutes to develop trained manpower of children with disabilities, to arrange work shops, seminars, symposiums and other activities for the help of handicaps



- d) To arrange for the over all activities of public utility and works and construction of Roads, Buildings, Religious Places, Shops, Dharmshalas, Sarai, Schools, Marriages Halls etc.
- e) To establish Universities, Colleges and Academic Centres, Professional Job Oriented Programmes, Rural Managements, Hotel Managements, Para Medical Certificate Courses and all such institutions which are necessary for the society at large.
- f) To establish Hostels, Deemed University, Research Institutions, Medical Diagnostic Centres, arrange for camps in all places of remote areas.
- g) To establish such institutions with the proper governance of University Grant Commission, Board of Secondary Education, Board of Technical Education, AICTE, MCI, DCI, INC, IRDA for all the students choosing for career in all walks of life.
- h) To establish rehabilitation centres for handicap students and physically disabled and mentally disabled students of the society.
- i) To establish old age, pensioner clubs and develop such centres which provide for the betterment and well being of the senior citizen of the society.

j) To establish such centres which provide for medical assistance and aide to accidental human being and to educate and impart training amongst the people of society for the eradication of pollution of all kind presents in the land.

k) To establish such centres which provide for the coaching and counselling for the premedical test, pre-engineering test, pre-legal examination and other faculties of professional training.

THE SETTLOR in perfect mutual concurrence and under standing has decided to constitute and form a "TRUST" for the pious purpose of spread of knowledge and education amongst the people in specified field of medical, social, economic and over all aspects of rural life including all sympathy to animals and live stocks of the rural areas.

## II. NOMENCLATURE :

The TRUST founded by SETTLOR by this instrument shall always be known as TRUST of "SHYAM LAL PANWAR ANANDI DEVI MEMORIAL CHARITABLE TRUST" For sake of brevity the TURST name could be mentioned as "WEER" hereinafter for short referred to as "the TRUST".

## III. FIELD OF INITIAL ACTIVITIES OF TRUST

The TRUST shall work initially in the State of Rajasthan specially in the District of JAIPUR with its first opening then the activities could be advanced to other States union territorial

#### IV. HEAD OFFICE OF THE TRUST

The Head Office of the TRUST will be at 135, Ram Nagar Ext. New Sanganer Road, Jaipur.

#### V. INITIAL CAPITAL

The TRUST is being started with an INITIAL CAPITAL of Rs. 10,000/- Rupees Ten Thousand only which is raised by actual contribution of members of the TRUST. And Govt. Grants of State & Govt. of India for Non Govt. organisation (NGO) and donations of any one else. To that activities can be extended up to most.

- (ii) Vacancy of the permanent member of the constituting body of the TRUST could be filled by majority decision of the existing other members of the constituting body.
- (iii) The member TRUSTEES shall always strive to achieve the objectives of the TRUST and thereby achieve the MAIN AIMS AND PURPOSES of the TRUST.
- (iv) No member of the constituting body of the TRUST shall ever have any personal interest or profit in the TRUST but the member shall always work with enthusiasm for the general and over all well being of the TRUST and to achieve main aims.

VI.

OBJECTIVES OF THE TRUST :

- a) To perform activities of help in suffering to humans.
- b) To assists and provide information of latest technical

know-how to rural people and village women.

- c) To provide motivational programmes in villages for weaker section's.
- d) To prepare and train rural people and women for spread and augmentation of such facilities to people through organisation of facilities to people in the medical care, health care, sanitation, medicine and treatment etc. to take up programmes of development of infants, expectant mothers, women and children, in all fields of medical activities.
- e) To provide relief to the sick, un healthy, poor, down trodden rural/urban slum dwellers.
- f) To impart the technical know how, machinery, equipment, apparatus and other necessary things used for the over all rural life style.
- g) To provide social & Economic Development of Poor, Men, Women & Children in All Rajasthan. To supply primary medical care women, children, man to observe the health care aspect.
- h) To organise training programmes for employment of rural women and youth.
- i) To give assistance and/or grant-in-aid to trusts, institutions, funds, individuals and/or other

organisations engaged in the furtherance of similar objectives and activities.

- j) To accept donations, gifts, endowments, settlements and contributions from individuals, Firms, Companies, Corporations, Association of persons, Government and Semi Government Institutions, Co-operative Societies and other countries etc.
- k) To take or accept loans, subsidy, aids, assistance, (both monetary and in kind) from International Organisations Central and State Government, Semi-Government, other Autonomous Bodies/Authorities, Institution, Funds, Boards for furthering objects of the TRUST.
- l) Generally to do all such other things as are incidental or conducive to the attainment of the above objects. The benefit from the activities of the TRUST shall be available to all persons without any discrimination on account of caste, creed, faith, religion, community, colour and sex.

VII. POWER AND FUNCTION OF THE CONSTITUTING

**BODY OF THE TRUST.**

For the furtherance of the objects of the Trust, the Trustees shall have the following powers :

- a) To accept any donation, contribution, grant or subscription in cash or in kind including any property from any person, body of persons, company or Trust on such terms and conditions as the Trustees may think fit.
- b) To apply the whole or part of the income of the Trust fund or accumulation thereof or whole or part of the corpus of the Trust Fund for any one or more of the objects of the Trust as the Trustees may decide from time to time.
- c) To invest and keep invested the Trust Fund or the income thereof either in the purchase or mortgage of immovable property or, in shares, stock or debentures or other securities and investments whatever authorized by the Indian Trust Act, 1882 or not or to keep in deposit with or loan to any company, bank, firm, or any other person in conformity with the provision of the Income Tax Act for the time being in force; and to alter, vary or transpose such investments may in their discretion think fit and proper.
- d) To convert and deal with the Trust property and/or to vary the investment for the time being.
- e) To borrow money for the purpose of the Trust and

management of its properties.

- f) To sell, alter, vary, transpose, dispose of, alternate or other wise deal with any property movable or immovable the Trust fund or any investment representing the same and to reinvest the same in any manner as the Trustees may think fit but always in the best and optimal interest of the TRUST.
- g) To appoint experts and other skilled persons in the services of the TRUST either on salary basis or on a contractual basis. The salaries, remuneration and other consideration shall always be paid out of the TRUST fund accumulated by the TRUST in due course of its income through donations and contributions etc.
- h) To open account with any bank or banks in the name of the Trust, to operate such account and to give instruction to the bank that such account may be operated upon by one or more of the Trustees or by one or more agents appointed by the Trustees.
- i) To adjust, settle, compromise, compound, refer to arbitration all actions, suits, claims, demands and proceeding regarding the Trust properties.
- j) To appoint constituted attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested in them under these presents and from time to time remove such attorneys or agents and to

appoint other or others in his or their place.

- k) To make, vary alter or modify scheme, rules and regulations for carrying out the objects of the Trust and for the Management of the affairs thereof the Trust and for the Management of the affairs thereof and of running any institution in furtherance of the objects of the Trust and other wise for giving effect to the objects of Trust.
- l) To set apart the whole or part of the income or the corpus of the Trust Fund for any of the objects of the Trust.
- m) To accumulate the income of the Trust and apply the accumulated income for one more of the objects.
- n) To pay all charges imposition and other outgoing payable in the respect of the Trust Fund or any property comprised in the Trust and also to pay all costs of any incidental to the administration and management of the Trust Fund for the time being.
- o) To appoint and/or dismiss officer or owner employees to look after and manage the properties constituting the Trust Fund and to allot to such persons such duties as the Trustees may think fit and proper.
- p) To give the donations and/or contribution to other Trusts and institution income be exempt under the provision of Income Tax Act.

- q) To join, co-operate with other Trust or Fund having kindred or allied objects upon such terms and conditions as the Trustees may in their discretion think fit.
- r) To appoint committees/Sub-committees for management and operation of various projects to under taken from the time to time.

**VIII. MEETING OF THE CONSTITUTING BODY OF THE TRUST**

- a) There shall be at least one meeting of the Board of Trustees in three months subject to a minimum of four meeting in a year.
- b) Three Trustees present shall form a quorum.
- c) All matters arising at a meeting of the trustees shall be decided by a majority of votes and in case of equality votes, the chairman of such meeting shall have a second or casting vote.
- d) A resolution in writing circulated amongst all the Trustees for the time being, shall be as valid and effectual as if it had been passed at a meeting of the trustees duly called and convened.
- e) The minute of the proceedings of every meeting of the constituting body of the TRUST shall be entered in book to be kept for that purpose and signed by the chairman of such meeting or of the following meeting.

IX. BANK ACCOUNT

The Trustees may from time to time open and maintain in the name of the Trust bank account or accounts and same shall be operated by the signatures of the persons on out of Chairman/ Honorary Secretary and the Treasurer of the Trust. The Accounts may also be operated by such Trustees or Officers as may be nominated by the Board of Trustees from time to time.

X. COMMON SEAL OF THE TRUST.


The TRUST shall always be represented by a common seal which will be universal and shall always contain the name of the TRUST as written in the nomen clature clause of this DEED.

XI. ACCOUNTS AND AUDIT

- a) The Trustees shall keep or cause to be kept true and fair accounts of all moneys received and disbursed or spent for the objects and the purposes of the Trust.
- b) The Trustees will appoint a Chartered accountant as the auditor of the Trust to conduct the Audit of the account of the Trust every year.

XII. RULES AND REGULATIONS

- a) The Trustees may from time to time make such rules and regulations for the management of the affairs of the Trust which rules and regulations shall always be in perfect consonance of the objectives of the TRUST and main AIMS AND PURPOSES of the TRUST.
- b) The Trustees may form such rules and regulations which



are in perfect harmony of the existing law of the land of  
Govt. of Rajasthan and Govt. of India.

**XIII. IRREVOCABILITY OF THE TRUST**

It is declared that the Trust is irrevocable and it will always be juridical person known by its common seal. If the Trust fails for any reason, in the opinion of the Trustees, the net assets of the Trust both moveable and immovable shall be handed over to any other Trust having the same object as decided by the majority of the Trustees.
